





Anti-Ragging Committee

A. Introduction: The College is dedicated to provide fearless, secure and conducive learning environment for the students. For this purpose, various statutory committees are established including Anti-Ragging Committee, Internal Complaints Cell, Student Grievance Redressal Cell, Equal Opportunities Cell, etc. All these committees aim at addressing issues or complaints of the stakeholders in the college campus. In the beginning of each academic year, IQAC organizes SIP i.e. Student Induction Programme where newly admitted students along with old ones being assembled together interacting on the issues like student safety etc. During this programme, they are given awareness regarding the various statutory committees constituted in the institution. They are familiarized with the institution's structures, mechanisms and procedures, including zero- tolerance policies and specific procedures for addressing student grievances. They are also given an overview of the institution, its various departments, facilities and the different student support and welfare activities carried out throughout the year. Students are addressed by their respective Heads of Departments/ committees during department specific induction meetings. The department association meetings are systematically conducted to address students' grievances and concerns. Anti- ragging instructions being given to them in programme and at individual level. To raise awareness among students, anti- ragging posters



are strategically placed at prominent locations on the campus such as corridors and verandas etc. In order to ensure students' awareness about the functioning of the cells and committees responsible for their rights and safety on campus, boards displaying the names and contact details of the respective cell coordinators are installed.

B. Objectives of the committee: The committee is formed to aware the students regarding the dehumanizing effect of ragging inherent in its perversity. To keep a continuous watch and vigil over ragging so as to prevent its occurrence and recurrence. Promptly and stringently to deal with the incidents of ragging brought to our notice. To generate an atmosphere of discipline by sending a clear message that no act of ragging shall be tolerated and any act of ragging shall not go unnoticed and unpunished. It aims to build a ragging free environment by instilling the principles of democratic values, tolerance, empathy, compassion and sensitivity to that students become responsible citizens and create an atmosphere of discipline by passing a clear message that no act of ragging in college premises

C. Anti-Ragging Regulations: This Cell is functional with the principal as the head, and three faculty members as coordinators. As per the order of Supreme Court of India and subsequent notification from University Grants Commission (UGC), ragging constitutes one or more of any intention by any student or group of students on:

- 1. Any act of Indiscipline, Teasing or Handling with Rudeness.
- 2. Any act that Prevents, Disrupts the Regular Academic Activity.
- Any activity which is likely to cause Annoyance, hardship, Psychological Harm or creates Fear or Apprehension.
- 4. Any Act of Physical Abuse causing Assault, Harm or danger to Health.
- 5. Any Act of abuse by spoken words, emails, SMS or public insult etc.
- 6. Any Act of injury or infringement of the fundamental right to the human dignity.
- Any Act of Wrongful Confinement, Kidnapping, molesting or committing unnatural offences, use of criminal forces, trespass or intimidation.





p. Punishment for violating the Regulations:

Any student or group of students found guilty of ragging in the campus or even outside the campus shall be liable to one or more of the following punishments.

1. Debarring from appearing in any sessional test / University Examination .

2. Suspension from attending classes and academic privileges.

3. Withdrawing scholarships and other benefits.

4. Suspension from the colleg.e

5. Cancellation of the admission .

6. Withholding of the results.
