## MRP PROJECT COMPLETION REPORT

We had applied for the minor research project entitled "USE OF THE INFORMATION ACT IN SONPETH TALUKA" and where sanctioned Rs.2,35,000/- vide letter no file No. 23- 805/13 dated 21 May 2014. Out of the sanctioned amount we revised the first instalment of Rs.1,00,000/- in June 2014. The second instalment of Rs.80,000/ Final project completion report along with utilization certificate is being submitted to your office UGC-WRO Pune For MRP work was divided in to three phases.

### i) Overall Findings of the Study

The findings of the small project research study on the use of RTI in Sonpeth taluka are summarized as follows.

The Central Government of India enacted the Right to Information Act across the country on 12 October 2005. Prior to the enactment of this Act, the country had the British Privacy Act of 1923. India was liberated from the yoke of the British in 1947 and has been a republic of India since 26 January 1950. In fact, the Privacy Act was supposed to be repealed at that time, but it wasn't until 2005. And the Right to Information Act 2005 came into existence. Since the enactment of the Right to Information Act, it has been used to some extent and misused to some extent. The following are some of the key findings of the study on how RTI has been used in Sonpeth taluka through a short dissertation.

- 1) The conclusion of the present subject is framed on the basis of objectives and assumptions. The present age is the age of information and technology. The Right to Information 2005 has been used to bring transparency, accountability, efficiency, and openness in governance, thus protecting the freedom and rights of ordinary citizens.
- 2) Maharashtra Right to Information Act 2000 Right to Information Act 2005 has proved to be more detailed and comprehensive than Maharashtra Right to Information Act 2002.
- 3) The Right to Information Act 2005 has been useful in rural areas like Sonpeth in terms of protecting democratic values, social justice, and human rights.
- 4) Due to the Right to Information Act 2005, the staff in the administrative offices of the government has become a part of the common man. This has led to some transparency in the administration and has helped reduce corruption.
- 5) Although the general public in Sonpeth taluka is exercising their right to information, its proportion is low and there is a great lack of public awareness about the Right to Information Act 2005.
- 6) Although it is true that RTI is used and misused, the rate of RTI misuse in Sonpeth taluka is very low.
- 7) In Sonpeth taluka, the right to information has been used especially by well-educated journalists and social activists, which shows that the common man in the society is ignorant about it.
- 8) There is more fear in the administration and the public about the Right to Information Act 2005 than the sense of rights and duties.
- 9) It is seen that the use of RTI by the women of Scheduled Castes and Scheduled Tribes in Sonpeth taluka is very low.
- 10) Where the RTI Act has been abused, it appears to have been based solely on personal grievances, so there is no need to take such misuse seriously.
- 11) According to the RTI Act, it is expected that administrative officers and ordinary citizens should not exercise this right instead of giving out information directly.



## ii) Recommendations


The use of RTI in Sonpeth taluka is based on the findings of the present small research project. Here are some suggestions on how to look or get an appointment for antique items. The purpose of suggesting such measures is to increase the use of the present law and create more transparency, honesty, and openness in the work of government administration to create a corruption-free administration.

- 1) Emphasis should be placed on making the attitude of the administration and the public positive towards the Right to Information Act 2005 so that the use of the Right to Information Act 2005 would be more widespread.
- 2) It is necessary to create awareness in the context of the Right to Information Act 2005 at the taluka level and village level in rural areas.
- 3) The post of Information Officer should be created in each administrative office and appropriate services should be provided to it.
- 4) Computerize the information and work of each administrative office so that it is easily available.
- 5) In order to create awareness about the Right to Information Act 2005, it should be included in the curriculum of schools and colleges and for that, debates, competitions, workshops, and seminars should be organized.
- 6) The RTI Act should be extended to government co-operatives and the private sector to curb corruption in the private sector.
- 7) Instead of making changes that would weaken the RTI Act, the government should take steps to make it more stringent.
- 8) Under the Right to Information Act 2005, a booklet has been published by each department providing information on the Assistant Information Officer, Public Information Officer and First Appellate Officer appointed in each public authority.

### iii) Specific Recommendations for ELT

- 1) Every public authority should have an RTI cell with RTI publications.
- 2) The government should prepare and publish a list of such governmental organizations which are under the control of the state government and which receive direct and indirect grants from the state government.
- 3) Information about the working of Gram Panchayat Public Authority at the village level should be displayed in the visible area and the topics of the monthly meeting and the decisions of that time should be displayed in the minutes list of all the decisions of the Gram Sabha from time to time.
- 4) As the same Village Development Officer has the authority of more than one Gram Panchayat and one Talathi Patwari has more than one current charge, as per the provisions of the Act, information can be provided within 30 days. The Gram Sevak should be strictly present in his Gram Panchayat and Talathi License on the day of appointment in order to make it available.

### प्रस्तावना :-

मानव अधिकार (Human Rights) हे नैसर्गिक अधिकाराचे आधुनिक रूप आहे. मनुष्य हा नैसर्गिक प्राणी आहे. मनुष्याचा सर्वांगीण विकास होण्यासाठी ज्या अधिकारांची आवश्यकता असते; ते सर्व अधिकार मानव अधिकार आहेत. रॅन्डमहाऊस या कोषात मानवाधिकाराची व्याख्या करताना असे म्हटले आहे की, मानव अधिकार म्हणजे व्यक्तीला जन्माने प्राप्त झालेले असे अधिकार जे व्यक्तीला सन्मानाने जगण्यासाठी आवश्यक आहेत मानवाधिकाराची सुरुवात १३ व्या शतकापासून झाली असे मानले जाते. इंग्लंडमध्ये सन १२१५ मध्ये मॅग्नाकार्टाचा जी सनद मान्य करून घेण्यात आली तेव्हापासून पुढे पिटिशन ऑफ राईट्स (१६२८) बिल ऑफ राईट्स (१६८९) अमेरिकन व फ्रेंच राज्यक्रांतीमधील स्वातंत्र्याचा जाहिरनामा आणि संयुक्त राष्ट्र संघटनेने १० डिसेंबर १९४८ रोजी जाहिर केलेला मानवाधिकाराचा जाहिरनामा असा हा मानवाधिकाराचा एकूण प्रवास राहिला आहे.

मानवाच्या विकासासाठी हितासाठी आणि कल्याणासाठी जे अधिकार आवश्यक आहेत ते सर्व अधिकार मानवाधिकार या संकल्पनेत येतात मग तो अधिकार राज्याने, समाजाने आणि कायद्याने मान्य केलेला असो अथवा नाही. स्वातंत्र्य, समता, न्याय आणि लोकशाही या संकल्पना दिवसेंदिवस व्यापक होत आहेत याचे कारण मानवाधिकार ही संकल्पना व्यापक होत आहे. त्यांना वैश्विक (Universal) स्वरूप येत आहे. मानवाधिकारात आता एका नव्या अधिकाराची भर पडली आहे. आणि तो अधिकार म्हणजे माहितीचा अधिकार (Right to Information) होय.

### शोध निबंधाची गृहितके :-

प्रस्तुत शोधनिबंधाचा अभ्यास करण्यासाठी पुढील गृहितकांच्या आधारे निष्कर्ष काढले आहेत.

१. माहितीचा अधिकार मानवाधिकार आहे.
२. व्यक्तीला माणूस म्हणून जगण्यासाठी माहिती अधिकाराची आवश्यकता आहे.
३. मानवाधिकार आणि माहितीचा अधिकार यांचा परस्पर जवळचा संबंध आहे.

**माहितीचा अधिकारी :-** राज्याची प्रमुख दोन कार्ये असतात. एक सकारात्मक कार्ये आणि दुसरे नकारात्मक कार्ये व्यक्तीच्या अनियंत्रित वर्तमानाला नियंत्रित करण्यासाठी राज्य काही नकारात्मक कार्ये पार पडते. याच अनुषंगाने व्यक्तीवर राज्याचे नियंत्रण राहावे म्हणून ब्रिटिश सरकारने सन १९२३ मध्ये ऑफिशियल सीक्रेट्स अॅक्ट हा कायदा पास केला. या कायद्यामुळे ब्रिटिश सरकारला राज्य करणे सोईचे झाले. राज्यकारभारात आलेल्या या गोपनीयतेमुळे जनतेचे शोषण करण्याचे एक हत्यार ब्रिटिश सरकारला मिळाले. तेव्हापासून हा कायदा सामान्य जनतेचे शोषण करणारा कायदा म्हणून अस्तित्वात होता. यामुळे सामान्य नागरिकाला शासनाच्या कोणत्याही कार्याची माहिती मिळत नव्हती. राज्यकारभारात पारदर्शकता नव्हती ब्रिटिश गेले तरी त्यांची शोषनाची आणि कारकुनांची बाबुशाही तशीच कार्यरत होती. अशा अमानवी कायद्या विरुद्ध थोर समाज सुधारक अण्णा हजारे यांनी १९९७ मध्ये आज्ञाद मैदान येथे जन अंदोलन केले. आणि नागरिकांना माहितीचा अधिकार मिळावा अशी मागणी केली.

माहितीचा अधिकार मिळण्यासाठी सन २००० साल उजडावे लागले. पुढे हाच अधिकार सर्व देशवासीयांना

मिळावा म्हणून अंदोलने झाली तेव्हा सन २००५ मध्ये भारतीय संसदेने माहितीचा अधिकार अधिनियम २००५ या नावाने कायदा केला. तेव्हापासून सर्व भारतीय नागरिकांना हा नविन मानवाधिकार प्राप्त झाला आहे.

### माहितीचा अधिकार २००५ :-

१५ जून २००५ रोजी महामहिम राष्ट्रपतींनी या अधिनियमावर सही केली. पण या अधिनियमाची प्रत्यक्ष अंमलबजावणी १२ ऑक्टोबर २००५ पासून झाली या अधिनियमात एकूण ३१ कलमे आहेत. भारतीय राज्यघटनेच्या मुलभूत अधिकारातील कलम १९ (१), (८) मध्ये माहितीच्या मानवी अधिकाराचे मुलस्रोत आहे. या कालमान्वये व्यक्तीला बोलण्याचा अधिकार आहे. बोलण्याचा अधिकार तेव्हाच पूर्णत्वास येवू शकतो, जेव्हा त्याला जे बोलायचे आहे त्याची पूर्ण माहिती असेल. म्हणून बोलण्याचा मानवाधिकार माहितीच्या मानवाधिकाराशिवाय उपभोगता येत नाही. जो मागेल त्याला आणि जी मागेल ती माहिती ठराविक काळात नागरिकांना मिळाली पाहिजे त्यामुळे शासनाचा कारभार आपोआपच पारदर्शक होतो आणि सामान्य नागरिकांचे शोषण थांबते.

या अधिकारामुळे सर्वांत महत्त्वाची गोष्ट जर कोणती झाली असेल तर ती म्हणजे, जी माहिती संसदेला किंवा राज्य विधानसभेला नाकारली जाऊ शकत नाही अशी माहिती कोणाही व्यक्तीने मागितली असेल, तर माहिती अधिकाऱ्याने ती त्या व्यक्तीला पुरवली पाहिजे. या तरतुदीमुळे सर्वसामान्य व्यक्ती व संसद सदस्य हे दोन्ही एका पातळीवर आले. आम्ही भारतीय नागरिक एक लोकतांत्रिक प्रजासत्ताक गणराज्य खऱ्या अर्थाने निर्मितीच्या दिशेने एक पाऊळ टाकले.

आपल्या देशाच्या राज्यघटनेत माहितीच्या अधिकाराच्या मुलभूत हक्क म्हणून स्पष्टपणे लेखी उल्लेख केलेला नसला तरी नागरिकांच्या मुलभूत अधिकारातच तो अस्तित्वात आहे. सर्वोच्च न्यायालयाने वेळोवेळी दिलेल्या निवाड्यातून तीन प्रकारची माहिती असल्याचे नमूद केले आहे. तसेच देशात माहितीचा अधिकार अस्तित्वात येवून जवळजवळ दहा वर्षे पूर्ण होत आहेत. या अधिकारामुळे अनेक घडामोडी घटतच भ्रष्टाचार, घोटाळे, कामकाजातील अनियमितता उघडकीस आली ऐवढेच नाही तर अनेक संसदे सदस्य मंत्री आणि मुख्यमंत्री यांना घरी जावे लागले दारिद्र्यरेषेखाली जीवन जगणाऱ्या व्यक्तीला रेशन मिळाल्या पासून ते पंतप्रधानाच्या परदेशवारी पर्यंतची माहिती सर्वसामान्य नागरिकांला उपलब्ध होऊ लागली.

परंतू एकीकडे माहिती अधिकारामुळे चांगल्या गोष्टी घडत असताना पारदर्शक व उत्तरदायी कारभार होत असताना दुसरीकडे अनेक कार्यकर्त्यांना प्राणास मुकावे लागले आहे. तर काहींवर प्राण घातक हल्ले झाले आहेत. तेव्हा हा अधिकार अधिक सक्षम होण्यासाठी शासनाने या संबंधी कठोर भूमिका घेतली पाहिजे. तसेच माहिती मागणाऱ्या व्यक्तीला अधिक संरक्षण दिले पाहिजे.
