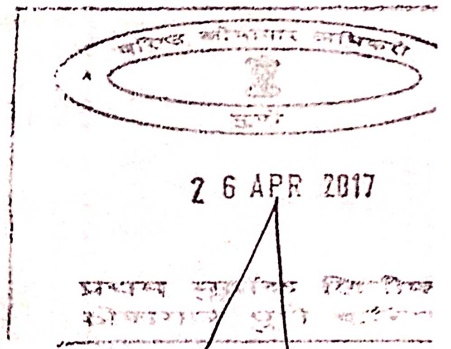

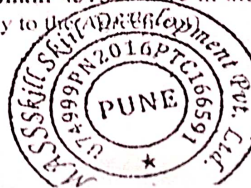


ASSOCIATE BRANCH REVENUE SHARING AGREEMENT

This Agreement is made and entered into on the Tuesday of 02 May in the year 2017 by and between MASSKILL SKILL DEVELOPMENT PVT.LTD., through its Authorized Signatory Aruna R. Nanaware, who is duly authorized & competent to sign the same, here in after referred to as the MSDPL (Also referred to as the First Party to the Agreement)

And

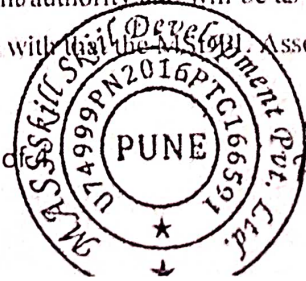

Whereas with reference to Clause number 4, 5 and any other that is concerned, in the Associate Branch Agreement dated of 02 May 2017 executed in the above named parties, the following terms and conditions are agreed and executed for the subject-matter of revenue cum finance sharing between MSDPL and MSDPL Associate Branch, viz:

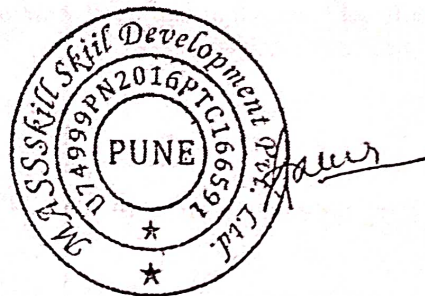
1. That the MSDPL Associate Branch shall be paid their share of amount on the basis of 'A' Grade Courses( Technical Courses )Rs. 10/- per student, per hour & 'B' Grade Courses ( Non-Technical ) Rs. 8/- per student, per hour for Pramod Mahajan Koushalya Va Udyojakta Vikas Abhiyan (PMKUVA) . For instance, if a course has 500 hours for 'A' Grade Courses( Technical Courses )of teaching per student, the MSDPL Associate Branch shall be paid Rs. 10/- multiplied by 500 hours of teaching which Rs. 5000 is/- per student.
2. That the MSSDS Registration fees, inspection fee and empanelment fee or charges to apply for new courses/programmes shall be paid by the MSDPL Associate Branch. In Case MSDPL pays the fees, the same will be deducted by the MSDPL out of its Associate Branch's share
3. That the MSDPL Associate Branch shall be paid 10% advance (For PMKUVA) of the total amount payable. This payment is subject to the receiving of due amount of the course from MSSDS to MSDPL. The payment shall be paid on the basis of students Attendance which must be 90% or above.
4. That the remaining 90% (PMKUVA) of the amount payable to the MSDPL Associate Branch shall be done on the completion of the given course, calculated on the basis of number of students passing the course and NOT number of students enrolled. The payment shall be paid on the basis of students Attendance which must be 90% or above
5. We Understand And Agree That Once The Batches Started And After Receiving The First Part Of The Payment If The Students Don't Appeared For Final Exams, This First Part Of Payment Taken For Those Absent Students Or Admission Cancelled Students, Will Be Deducted From The Final Amount
6. That the Associate Branch must understand and agree Here with that the process of Empanelment & approval for the batches subject to the receiving it from MSSDS to MSDPL.
7. MSDPL should NOT be held responsible for any delay in receiving the TBN (TRAINING BATCH NUMBER) or for delay in the start process of the batches or scheduling Exams and receiving Certificates as MSSDS which is Maharashtra Government's Nodal Body, sends all this after thorough verification audit.
8. That the MSDPL will pay/credit MSDPL Associate Branch's share at the earliest after receiving such payments from the concerned government department/authority and will be as par the mutually understood terms and conditions and maintains here with that the MSDPL Associate Branch have NO





OBJECTION for this.

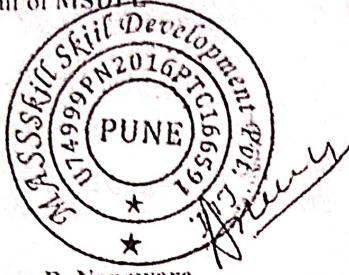
9. We Also Understand And Agree That If There Is A Delay In Receiving The Training Batch Number From The MSSDS And We Are Ready To Wait To Start The Batches Till We Receive The TBN's
10. That the Associate Branch must understand and agree here with that MSDPL should NOT be held responsible for any delay in releasing the 10% or 90% amount as MSSDS which is Maharashtra Government's Nodal Body, sends it to the MSDPL after the thorough verification.
11. That The MSDPL associate branch proclaims here with that they have NO OBJECTION on carrying out all the online work on behalf of the MSDPL ASSOCIATE BRANCH on the MSSDS portal.
12. That The MSDPL ASSOCIATE BRANCH must abide them for rendering quality training to the shortlisted and counseled students and Placement Responsibility lies with both. MSDPL & MSDPL ASSOCIATE BRANCH
13. That the MSDPL Associate Branch will NOT act in any way or manner, which is detrimental to the interest of the MSDPL and vice-versa.
14. That the MSDPL Associate Branch will be loyal to the Parent Company which is MSDPL PVT LTD and will not register itself as a separate MSSDS Partner in the same location till it continues to be the MSDPL associate branch.
15. That the Associate Branch shall not be able to use their VTP ID ( CEMP8658 ) registered with MSSDS under VTP NAME ( MSDPL, Late Ramesh Warpudkar Arts , Commerce & Science College, Sonpeth ) as the Registration fees is paid by MSDPL and hence it is the property of MSDPL and the whole rights to operate under this VTP ID are reserved with the company.
16. That this agreement embodies the agreement in consonance with Associate Branch Agreement dated 02 May 2017 between the parties hereto and supersedes any and all prior or contemporaneous, oral or written understanding, negotiations, or communications on behalf of such parties in respect of the subject matter herein.

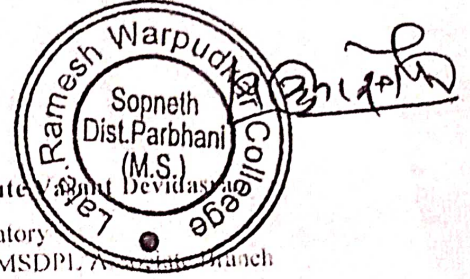
